Discussion with Felix Mayle, Conservation Project Officer, Heritage Lincolnshire.

Heritage Lincolnshire are launching a new twelve month project to engage communities in identifying and recording non-designated heritage assets that local people feel are important to the character of the towns and villages that they live in. Ultimately buildings (or other assets such as parks, archaeology etc) identified would be put forward for nomination to a Local Lists of Heritage Assets held by the local authority. 080921/7 Highways/Footpaths/Public Right of Way

- a) Updates on the following and action resolved:
- New village name sign – Cllr Simpson is liaising with Lee Collins for the photo.
 - Saxby Mill Lane, Dannels Hill and North Carr Lane repair works – works planned for Dannels Hill. The temporary repairs on Saxby Hill are poor.
 - Village stiles accessibility – the landowner is not keen on removing the stile. The PROW sign on Saxby Hill is rotten.
 - Maintenance of bus shelters - ongoing.
 - Seating/bench provision at Fairies Field– Cllr Simpson will liaise with Ongo who manage the land.
- b) The proposal by the Low Villages Forum to have 2 Morelock Battery Powered MSID Vario Radar Speed Signs to be shared by all 6 villages. Cost £667.50 per village was considered. It was agreed to contribute to the cost, preferably equally split across all 6 villages utilising the unused Neighbourhood Plan money and the solar battery option.
