Public Participation

Parish Council VE 75 Day update (via Cllr Simpson):

- Battle of Britain Memorial Flight – flypast has been requested. Worlaby Parish Council has also put in a request. RAF have not finalised routes yet but normally endeavour to cover as many areas as possible.

- North Carr Lane – due to recurrent flooding, the PC has requested that the drains are cleaned. NLC have confirmed that a tanker will attend soon.
- Speeding through the village – a resident has reported that incidences are increasing. It was noted that the village is a low priority for the mobile camera van. The Humberside Police and Crime Commission are spearheading an initiative called Community Speedwatch. Volunteers (16) have been recruited from the Low Villages and they will be trained to operate a speed detection device.
In the meantime, Cllr Simpson advised that if there are persistent speeders i.e. same time every day, residents can refer the matter to the police.
- NLC offer of transference of responsibility for grass cutting to town and parish councils – Clerk will request extension to the end of April 2020.
