## **Public Participation**

- Accessibility of pushchairs/wheelchairs via the village stiles – this will not be possible but a solution to accessibility could be by replacing the stiles with a clapper gate. Any replacement gate would need to ensure that cattle/sheep cannot escape from the field. Additionally, permission must be received from the landowner before any changes are made. Clerk to contact NLC in the first instance to enquire whether the stiles can be replaced.
- Footpaths – encroaching hedges are a concern due to the danger they cause by reducing visibility when exiting side roads i.e. Park Lane. Property boundaries also appear to have become unclear over time. Cllr Simpson commented that perhaps the PC could take a more proactive stance and speak to the owners of the properties in question to request that they maintain their hedges. Cllr Sherwood advised that the Clerk should contact NLC and request the professional opinion of a Highways Officer who will address the matter if they feel it is of concern.
- Dog bin – resident has requested the relocation of the new dog bin from Main Street (opposite to North Carr Lane) to North Carr Lane by the electrical substation.
- Green Team – resident queried whether there is a job list that residents could have access to so that they could assist with the tasks when they have time available. Cllr Simpson will create a list and post in the notice boards on Main Street and at the church.

- The Community Speedwatch initiative is popular with residents who are attempting to address speeding in their villages, however, Cllr N Sherwood felt that the most successful way to deal with speeding would be 'average speed' cameras. Unfortunately, these would be prohibitively expensive for NLC to install in all areas. Additionally, any revenue generated from fines would be appropriated by Humberside Police.
- Cases of COVID-19 is increasing significantly which may in part be caused by more testing, asymptomatic care home staff and those aged 18 to 25 years. NLC are pushing for all care home staff (included those in private homes) to get tested.

## 5. Highways/Footpaths/Public Right of Way

### a) Updates on the following and action resolved:

- New village name sign – Cllr Simpson has a site meeting with a NLC Highways Officer at 10am on the 24<sup>th</sup> September 2020 to discuss location and sizing requirements.
- Location of dog bin – the relocation of the new dog bin from Main Street (opposite to North Carr Lane) to North Carr Lane was agreed.  
Proposed: Cllr Simpson, seconded: Cllr Mitchell.  
The bin had been taken down by a resident that has now left the village and is lying behind a hedge nearby. Clerk to contact NLC to confirm that the new arrangement is satisfactory. Cllr Simpson and a nearby resident have agreed to keep the new location bramble-free.
- Speeding in the village – the Community Speedwatch initiative needs volunteers. A three-person team is required on each occasion: one to operate the speed measuring device, one to identify the car details and one to record the information. A recurring speeding motorist will initially be sent two letters, then a visit from a Safer Roads Humberside Officer and then finally a fine. A vehicle speeding excessively (e.g. 60mph in a 30mph zone) will swiftly trigger the placement of a camera van or bike. Locations for the Community Speedwatcher's is determined by Safer Roads to ensure it complies with legislation. It has been found that speeding initially reduces but builds back up after a few weeks as word gets around.  
Cllr Simpson and Clerk will create an information and volunteer request leaflet that will be delivered to those living on Main Street.
- 450 bus service termination and 'JustGo' North Lincolnshire service – service began on the 7<sup>th</sup> September 2020.
- Saxby Mill Lane, Danns Hill and North Carr Lane repair works - outstanding.
- Village stiles accessibility – see public participation.

### b) Other issues – overhanging trees on Church Lane. Clerk will contact the NLC Environment Officer to request a site visit.

## 6. Asset Management

- Cllr Simpson gave thanks to Mr and Mrs Bates for painting the bus shelter at Faeries Field.
- The bus shelter at the Horkstow end was painted by Cllr Simpson and Mr M Nugus. Cllr Simpson also gave thanks for his assistance in the task. They also repaired the damaged floor with new cement.
- The Monument has had the loose slabs re-cemented and re-laid with thanks to Mr M Nugus.

N.B. Members noted Public Sector Audit's report recommendation regarding NALC's 2018 briefing note that made councils aware that section 8 of the 1984 Local Government Act prohibits a Parish Council from incurring expenditure on "property relating to the affairs of the church or held for an ecclesiastical charity". It is NALC's view that this prohibition still applies and is not overridden by the general provisions of section 137 of the 1972 Local Government Act. Section 137 expressly provides that expenditure cannot be incurred for purposes which are subject to statutory prohibition, restriction or limitation and cannot, therefore, be used for the maintenance or upkeep of property or land owned by the church.

Members agreed that due to the Church's fundraising curtailments enforced by COVID-19 restrictions this year and mindful of a long history of this grant payment from the PC, funding would be approved. This matter will be looked at again in 2021.
